Articles of Association Japan East-West Center Alumni Association, Nagoya Chapter (Translation)

Chapter 1: General Rule

- Article 1 The name of this association shall be called Japan East-West Center Alumni Association, Nagoya Chapter
- Article 2 The object of the Association shall be to promote friendship among the members, and to further enlighten the members through the sharing of experiences and networking of information, thereby developing friendly relations and deepening international mutual understanding.
- Article 3 The Office of the Association shall be located in a place decided by the Board of Directors.

Article 4

- 1. Membership of the Association is divided into four categories: Regular Members; Associate Members; Honorary Members, Senior Members and Support Members.
- 2. Regular Members: Japanese grantees of East-West Center Scholarship or participants of Programs
- 3. Associate Members: Foreign grantees staying in Japan under the East West Center Programs.
- 4. Honorary Members: Regular Members who contributed to the Association greatly, subject to approval by the Board of Directors.
- 5. Senior Members: Regular Members who offer for oneself, subject to approval by the Board of Directors.
- 6. Support Members: Supporting Members, subject to approval by the Board of Directors.

Chapter 2: Organization and Organs

Article 5 The Association shall have the following three organs such as General Meeting, Board of Directors, and Auditors

General Meeting

Article 6 The General Meeting shall:

1. Be the highest decision body of the Association.

- 2. Hear the report of activities, and approves the budget of income and expenditure and the settlement of accounts.
- 3. Elect the directors and the auditors.
- 4. Decide on any other important matters pertaining to the Association's management.
- 5. Decide by the majority of members present.

Board of Directors and Auditors

- Article 7 Board of Directors shall have a Chairperson, a few Vice Chairs, a few directors in charge of organization, planning, public relations, accounting and others, and a few auditors.
- Article 8 The term of office of a Director, and an Auditor shall be two years. They shall be eligible for re-election.

Chapter 3: Activities and Accounts

Article 9 The Association shall carry out the following activities.

- 1. Conduct seminar and party to activate the exchange and deepen friendly relations among the members.
- 2. Activate to exchange and deepen relations among foreign East-West Center's related persons.
- 3. Organize party for invited grantees supported by the East-West Center.
- 4. Conduct activities designed to deepen international mutual understanding, as well as those deemed necessary to the Boards of Directors.
- Article 10 Expenditures incurred by the Association for its management shall be financed by membership dues, donation, and other miscellaneous income.
- Article 11 Annual membership dues shall be \pm 1000 for Regular Members and Support Members, and \pm 500 for Associate Members, while Honorary Members and Senior members with offer for oneself shall be exempted from the dues.
- Article 12 The association's fiscal year shall start on April 1 and end on March 31 on the following year.

Supplementary rule This rule for the Association shall start on May 30, 2009.
